The above article (hereinafter termed 'the Article'), will be published in *PHRONEMA* (hereinafter termed 'the Work') by St Andrew's Greek Orthodox Theological College of 242 Cleveland Street, Redfern 2016 (hereinafter termed 'the Publisher') under the editorship of Angelo Karantonis, (hereinafter termed the 'Editor').

1. Textual and Illustrative Material from other Sources

The Author/s will obtain at his or her own expense written permission from copyright owners for the use in the Article of original matter from the works of others, whether it be textual, tabular, illustrative or in any other form. The Author/s will deliver to the Editor or Publisher for their safekeeping copies of any documents relating to the granting of the said permissions.

2. Rights granted to the Publisher

2.1 The Author/s hereby grants to the Publisher for any Articles made by the Author/s for the full period of copyright the sole and exclusive right and licence to produce, publish, sell, license and exploit, and further to license the production, publication, sale, sub-licensing and exploitation of the Article in the Work or any adaptation, abridgment or substantial part of the Article in the Work throughout the world in any language in all forms (including all electronic forms).

2.2 The Publisher shall have the right to edit the Article in the Work for the original printing and for any reprinting, provided that the meaning of the text is not materially altered. The Publisher shall have the right: (1) to publish the Article in the Work in suitable style as to format, paper, cover design, printing and binding; (2) to fix or alter the title, price and terms of sale; (3) to use all customary means to market the Work.

3. Copyright in the Work

The copyright in the Work shall remain the property of the Publisher and all rights in, and for, any Article made by the Author/s will be owned by St Andrew’s Greek Orthodox Theological College in the Work. The copyright line shall read: **Copyright** © St Andrew’s Greek Orthodox Theological College (Year of publication)

4. Warranty and Indemnification

4.1 The Author/s hereby warrants to the Editor and Publisher that the Article is an original work and has not been published previously.

4.2 The Author/s warrants to the Editors and Publishers that the Article is in no way whatever a violation of any existing Copyright, or a breach of any existing agreement, and that all statements contained therein purporting to be facts are true and will indemnify the Editors and Publishers against any loss, injury or damage occasioned by the Editors and Publishers in consequence of any breach of this warranty or arising out of any claim that the Article constitutes an infringement of Copyright or contains defamatory or libellous matter.

5. Checking of Proofs

The Author/s will promptly and thoroughly check and return all proofs to the Editor who will return same to the Publisher within 72 hours of receipt, failing which the Publisher may consider the proofs passed for press. The Author/s will mark typesetting errors for correction. Any other changes sought by the Author/s at the proofs stage will be made at the discretion of the Publisher.

6. Author/s’s Copy

The Publisher will supply each Author/s with one free copy of the Work on publication.

7. Promotion of the Work

The Author/s agrees that his or her name can be used in promotion of the Work by the Publisher.

8. Moral Rights

8.1 Subject to paragraph two below, the Publisher will respect the Author/s's Moral Rights in the Article.

8.2 To the extent permitted by law, the Author/s gives their genuine consent in favour of the Publisher, their successors and licensees and any person authorised by them, in relation to any and all acts or omissions (whether occurring before or after this Agreement is signed) which relate to the exercise of rights and the performance of obligations of the Publisher under this Agreement and which are necessary to publish the Article in accordance with the terms of this Agreement or as otherwise agreed between the Author/s and the Publisher including without limitation:

- a) the reproduction, adaptation, publication and communication to the public of the Article in all mediums whether now known or later developed;
- b) failing to correctly credit the Author/s where the context does not permit;
- c) material alterations to the Article such as those which arise from editing, aggregating and disaggregating text, proof correction, typographical arrangement, translation or in accordance with legal advice;
- d) quoting and extracting excerpts and indexing;
- e) determining price, print runs and discounts for the Work;
- f) continuing to identify the Author/s as the author of the Article once the acts or omissions referred to in this clause have occurred; and
- g) any and all subsequent dealings with the Article after the acts or omissions referred to in this clause have occurred.

This clause survives the termination or expiry of this Agreement.
